


# *A Bit Better* News From First 5 Santa Cruz County

## Advocacy Efforts Elevate the Importance of Early Childhood Issues and Parent Voices

During these past few weeks of May, the <u>Central Coast Early</u> <u>Childhood Advocacy</u> <u>Network</u> (CCECAN) virtually hosted several local legislators to join in the conversation



about current issues directly affecting families with young children. Legislators and their staff had the opportunity to hear from community voices including parents and partners advocating for CCECAN's priorities. These priorities include stabilizing and strengthening child care and early childhood systems, ensuring that schools safely reopen, expanding access to mental health services and increasing housing and financial stability. Lizeth Santana, a Live Oak Cradle to Career parent leader, shared during one recent meeting that "I like to find spaces where we can connect with stories, that's where I realize that we all have challenges on the path of motherhood. I believe that these spaces, rather than giving us tools, connects us with a support network that strengthens us, for me that is the most gratifying."

The CCECAN partners from the counties of Monterey, Santa Benito and Santa Cruz represent over 94,000 young children. First 5 Santa Cruz County is a founding member of the network that was formed in early 2018 to help coordinate regional efforts and amplify community voice in support of just and equitable policies and systems for all children and families on the Central Coast. "What started as a nascent idea to collaborate regionally on policy advocacy for young children and families, has blossomed into an amazing partnership of parents and early childhood systems leaders acting collectively in the interest of young children and families in our region" said David Brody, Executive Director of First 5 Santa Cruz County.

Additional advocacy efforts took place statewide in late April when First 5 Santa Cruz County joined other First 5's from across the state on our annual Advocacy Day to raise awareness with legislators about First 5's current work and priorities. These include supporting families to be resilient, access to quality early learning, developmental screenings and comprehensive health care coordination, and the sustainability and scale of systems and services for children and families. Legislative visits specifically addressed the needs for early childhood mental health and trauma support, health equity for young children and mothers, the need for increased investment in child care, and equitable financial stability policies. - Share your ideas about how Santa Cruz County's Network of Care can continue to provide a space to learn together, center community voice and leadership, and advance racial equity through antiracist practices and policies.

## Child Care Providers Share Why They are Getting Vaccinated in New Video Series

"I'm getting vaccinated so I can invite families back into the classroom," says preschool provider Desiray Taylor. Over the past year, child care providers have put their lives on the line for the children and families they serve. Now, all individuals ages 12 and older in California are eligible to get the COVID-19 vaccine, including essential workers like early care and education providers. It's normal to be nervous about a new vaccine, but all of the vaccinations available are safe and effective at preventing serious illness —and getting vaccinated can help you and your community return to normal life. Child care providers from around the state, like Desiray, share why they got vaccinated in a new series of videos from **First 5 Association** and **First 5 California**. They share reasons like protecting their community, keeping their students and families safe, and helping to end the pandemic.
